Move ups:

A dog receiving a title after the closing date may be moved up to the next higher level by notifying the secretary on or before Monday, April 22th, 2019 at 8:00 PM. Please email move-up requests to Andrea Lengi at andrea@allamericandogsports.com. Move-ups will allowed between days during the trial.

Day of show Entries:

We will accept day of trial entries if the trial does not fill. The day of trial entry fees will be \$15.00 per class with no packages.

Refunds:

Refunds are allowed if requested before the closing date. There will be no refunds for entries withdrawn after the closing date for any reason other than bitches in heat. There will be no refunds in the event that a dog and/or a handler are dismissed from competition regardless of reason for such dismissal. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. The organizing committee may refuse any entry as provided through NADAC rules and regulations. Anyone not in good standing with NADAC will not be allowed entry in the trial.

Confirmations:

Preliminary confirmations will be sent within a week of receipt of your entry. Final confirmations will be sent once the trial has closed. Please read over your confirmations carefully. We will be happy to make corrections as long as we are notified prior to the final move up date, after which the scribe sheets and running orders are printed. If you do not receive a confirmation within a week of sending in your entry or a week after the closing date (April 17, 2019) please e-mail the trial secretary and let her know.

Food info:

We will provide water and snacks for workers. Lunch on Saturday will be potluck – bring something to share! We will provide pizza for lunch on Sunday, free for workers or \$5 for non-workers. A grocery store and fast-food restaurants are located within 5 minutes of the trial grounds.

Volunteer info:

We will post a large Worker Schedule near the ring where you can sign up to work the classes and jobs that YOU prefer to work! Remember, the Worker Schedule must be filled out and workers assigned before each class can begin. Thank you in advance for the generous contribution of your time and energy! Water and snacks will be provided for everyone who volunteers.

Awards and Ribbons:

Ribbons will be awarded for 1st through 4th place in each jump height for all classes in all Divisions excepting Chances, which is a pass/fail class. Qualifiers will receive a qualifying rosette. Anyone who achieves their NATCH at the trial will receive a special NATCH ribbon. New Title rosettes and New Award rosettes are also available.

JUMP HEIGHTS

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

Brief Summary of Rules:

Please refer to www.nadac.com for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted. <http://nadac.com/afirm/dogregfrm.asp> A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: www.nadac.com
- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No collars, leads, food, toys, clickers, or other aids or devices shall be permitted on the course. No, food, toys, clickers within 10 feet of the ring. Food or small toys can be in a secure container in pocket during a containerized trial.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.

1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.

1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5. Exhibitor/owner releases NADAC (including its respective officers, directors, employees, and members), **All-American Dog Sports** (including its officers, directors, members, and event organizing committee), and Montgomery County Parks and Recreation (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes sole responsibility for and agrees to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons

Exhibitor understands there is a returned check fee of \$25.

THE MANAGEMENT will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee be asked to leave the show site. In such case, no refund of fees paid will be made.

DIRECTIONS TO TRIAL SITE

The trial will be held outdoors on grass at the Town of Blacksburg Park at 725 Patrick Henry Drive, Blacksburg, Va 24060. This is a public park, so please do not leave personal belongings at the site overnight.

From I-81 North or South, take Exit 118B and get on US460 West towards Blacksburg. (Exits 118 A, B, and C all exit together and split up later.) Drive approximately 10 miles (past Va Tech) and take the Tom's Creek Road exit. Turn right onto Tom's Creek Road. Drive 0.2 miles and turn left onto Patrick Henry Drive. Drive 1.3 miles, and turn right into the Blacksburg Community Center parking lot.
