This trial is outdoors on grass. Please bring your own shade. This is a public park – tents and crates may be left overnight at your own risk.

**Entry Limits:**

400 runs per day

**Move ups:**

A dog receiving a title after the closing date may be moved up to the next higher level by notifying the secretary on or before Monday, April 20th, 2020 at 8:00 PM. Please email move-up requests to Andrea Lengi at [andrea@allamericandogsports.com](mailto:andrea@allamericandogsports.com). Move-ups will be allowed between days during the trial.

**Day of show Entries:**

We will accept day of trial entries if the trial does not fill. The day of trial entry fees will be \$15.00 per class with no packages.

**Refunds:**

Refunds are allowed if requested before the closing date. There will be no refunds for entries withdrawn after the closing date for any reason other than bitches in heat. There will be no refunds in the event that a dog and/or a handler are dismissed from competition regardless of reason for such dismissal. No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. The organizing committee may refuse any entry as provided through NADAC rules and regulations. Anyone not in good standing with NADAC will not be allowed entry in the trial.

**Confirmations:**

Preliminary confirmations will be sent within a week of receiving your entry. Final confirmations will be sent once the trial has closed. Please read over your confirmations carefully. We will be happy to make corrections as long as we are notified prior to the final move up date, after which the scribe sheets and running orders are printed. If you do not receive a confirmation within a week of sending in your entry or a week after the closing date (April 15, 2020) please e-mail the trial secretary and let her know.

**Food info:**

We will provide water and snacks for workers. Lunch on Saturday will be potluck – bring something to share! We will provide pizza for lunch on Sunday for volunteers. A grocery store and fast-food restaurants are located within 5 minutes of the trial grounds.

**Volunteer info:**

We will post a Worker Schedule near the ring where you can sign up for the classes and jobs that YOU prefer to work! Remember, the Worker Schedule must be filled out and workers assigned before each class can begin. Thank you in advance for the generous contribution of your time and energy!

**Awards and Ribbons:**

Ribbons will be awarded for 1<sup>st</sup> through 4<sup>th</sup> place in each jump height (except Chances, which is pass/fail.) Qualifiers will receive a rosette. Anyone who achieves their NATCH at the trial will receive a special NATCH ribbon. New Title, New Award, and Debut rosettes are also available.

### JUMP HEIGHTS

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

## Brief Summary of Rules:

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted. <http://nadac.com/afm/dogregfrm.asp> A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: [www.nadac.com](http://www.nadac.com)
- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No food, clickers, or other aids or devices shall be permitted on the course or within 10 feet of the ring. Food or a small non-audible toy can be in a secure container (ziplock bag is acceptable) in your pocket during your run but it cannot be used during your run, nor can you indicate to the dog it is there. Only Intro and Novice handlers may bring a non-audible toy into the ring for training purposes. They cannot earn a Qualifying score and must declare to the judge they are training before they commence their run. Please read the Exhibitor's Handbook for more information about toys and training in the ring.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

## AGREEMENT

1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.

1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.

1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5. ### **DIRECTIONS TO TRIAL SITE**

The trial will be held outdoors on grass at the Town of Blacksburg Park at 725 Patrick Henry Drive, Blacksburg, Va 24060. This is a public park, so please do not leave personal belongings at the site overnight.

From I-81 North or South, take Exit 118B and get on US460 West towards Blacksburg. (Exits 118 A, B, and C all exit together and split up later.) Drive approximately 10 miles (past Va Tech) and take the Tom's Creek Road exit. Turn right onto Tom's Creek Road. Drive 0.2 miles and turn left onto Patrick Henry Drive. Drive 1.3 miles, and turn right into the Blacksburg Community Center parking lot.
